Section 1. The Borough of Ogdensburg, in the County of Sussex, New

Jersey (the "Borough") is hereby authorized to design and construct an emergency

generator for well No. 3, by and for the Water Utility of the Borough. Said improvements shall include all work, materials and appurtenances necessary and suitable therefore.

Section 2. The sum of \$87,500 is hereby appropriated to the payment of the cost of the improvements authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from Water Utility Capital Surplus of the Borough. The sum of \$87,500 is hereby appropriated from Water Utility Capital Surplus of the Borough to the payment of the cost of said purpose.

Section 3. Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.

Public hearing and adoption is scheduled for August 10, 2009.

BE IT ORDAINED by the Borough Council of the Borough of Ogdensburg, in the County of Sussex, New Jersey, as follows:

Section 1. The Borough of Ogdensburg, in the County of Sussex, New Jersey (the "Borough") is hereby authorized to purchase a water utility truck and snow

plow, by and for the Water Utility of the Borough. Said improvements shall include all work, materials and appurtenances necessary and suitable therefore.

Section 2. The sum of \$41,000 is hereby appropriated to the payment of the cost of the improvements authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from Water Utility Capital Surplus of the Borough. The sum of \$41,000 is hereby appropriated from Water Utility Capital Surplus of the Borough to the payment of the cost of said purpose.

Section 3. Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. Robert Tessier, Director of Planning from Dykstra Associates, Inc. attended the meeting to give a short presentation on Module 1 and the Highlands Regional Master Plan Conformance. Mr. Tessier spoke about developable and non developable properties. Dykstra will need approval from council to meet with the Highlands Council to discuss further work with the modules.

Councilman Wood moved, Councilman Ingerto seconded motion to open the public session. Yeas: Ingerto, Wolstenholme, Wood.

Christopher Swank 12 Adams Drive addressed council regarding a zoning permit for a swimming pool, which was denied because he did not get a variance. There was discussion on the ordinance regarding swimming pools and the definitions of backyards, side yards and front yards. Councilman Wood stated if the ordinance states a variance is needed then the resident should get a variance. Proper protocol should be to get a variance. Councilman Wood also mentioned that the topic needs to go back to the Land Use Board. from 24 Richardsville Road also inquired about temporary pools and whether you need a permit for a temporary pool. Resident stated he puts up and takes down a temporary pool every year and would he need a permit every year. Mayor Sekelsky said he would have to find out. Resident also inquired about an easement on his property. Joseph Concoy, 12 Beardslee Hill Drive mentioned a tree which may be falling down and children cutting through his property to get to the ball field. Mr. Concoy discussed an easement which there were some questions regarding who owned the easement. Mr. Concoy also talked about an ordinance for barking dogs. Mr. Concoy called the police twice regarding the noise. Police Commissioner said he will have the Chief look into the situation. Mr. Peist, Grant Terrace inquired if the town is purchasing allocation for Franklin. Mayor informed Mr. Peist no the Borough is not pursuing any allocation. Mr. Peist informed Mayor and Council about the fire alarm on the Historical building that when it goes off it is causing sparks and it needs to have an electrician look at it. Mr. Piest also inquired about the gas line coming through town and if it could be negotiated. Mayor informed Mr. Peist that it is through the county and asked for any information to be put in writing. Mr. Peist inquired about any process going on for dredging of Heaters Pong. Mayor response was no.

There being no further business from the public, Councilman Wood moved, Councilman Ingerto seconded motion to close the public session of the meeting. Yeas: Ingerto, Wolstenholme, Wood.

At 9:30 p.m. Councilman Wood moved, Councilman Wolstenholme seconded motion to go into executive session to discuss personnel matters. Yeas: Ingerto, Wolstenholme, Wood.

After returning from executive session at 10:15p.m., Mayor and Council continued with the regular meeting.
