Councilman Hann moved, Councilman McGuire seconded motion to open the public hearing on an ordinance entitled **AN ORDINANCE AMENDING THE SALARIES OF THE POLICE OFFICERS OF THE BOROUGH OF OGDENSBURG THEREFORE**. Yeas: Amodeo, Andrews, Hann, Ingerto, McGuire, Opilla.

Councilman Andrews moved, Councilman McGuire seconded motion to introduce an ordinance entitled **AN ORDINANCE TO AMEND CHAPTER XXX OF THE CODE OF THE BOROUGH OF OGDENSBURG, NEW JERSEY, BEING THE ZONING CODE OF THE BOROUGH TO PROHIBIT OUTDOOR FURNACES AND OUTDOOR WOOD BOILERS** on first reading. Public hearing is scheduled for December 10, 2012.

BE IT ORDAINED by the Borough Council of the Borough of Ogdensburg, County of

Sussex and State of New Jersey that Chapter XXX of the Code of the Borough of Ogdensburg,

being the zoning chapter, shall be and hereby is amended as follows:

SECTION 1. Section 200 of the zoning chapter entitled "Definitions and Descriptions"

is hereby amended by the addition of the following definition to read in its entirety as follows:

Outdoor Furnace: Any equipment, device, appliance or apparatus, or any part thereof, which is: (a) installed, affixed or situated outdoors; (b) wood, biomass and/or pellet-fed;

and (c) utilized for the purpose of combustion of fuel to produce heat or energy used as a component of a heating system providing heat for any interior space or water source. This term includes but is not limited to wood boilers.

SECTION 2. Section 401 of the zoning chapter entitled "General District Regulations"

is hereby amended to add the following language to the existing section:

§ 401 General District Regulations.

...Outdoor furnaces are prohibited in all zone districts. No accessory structure shall be permitted to house or enclose an outdoor furnace.

SECTION 3. If any provision of this ordinance or the application of this ordinance to

any person or circumstances is held invalid, the remainder of this ordinance shall not be affected

and shall remain in full force and effect.

SECTION 4. All ordinances or parts of ordinances or resolutions that are inconsistent or

in opposition to the provisions of this ordinance are hereby repealed in their entirety.

SECTION 5. This ordinance will take effect after publication and passage according to law.

NEW BUSINESS

Councilman McGuire mentioned in regard to the E-Waste program that the Mayor is trying to clean out the recycling garage at the present moment. Would like to table discussion until the next meeting. With regard to the New Jersey Clean Communities Council's Adopt a Beach program, Councilman McGuire will speak with the ORA to see if they would like to take it on. Councilman McGuire also spoke about the budget line for lifeguards is \$400.00 over. The reason being is from the swim meet. Councilman McGuire spoke to the head of the swim team

and was informed that they only have \$20.00 left in their budget due to spoilage of food over the summer. The Borough will cover it, but for next year the ORA will have to budget for the additional lifeguards for the swim meets. Project Self Sufficiency for Sussex County is in partnership with Warren County and is looking for all the towns in Sussex County to show support for their program on child sexual abuse. This has been tabled until next meeting.

It was mentioned that any pieces of furniture left from the auction will be thrown out. Also discussed was garbage that is put behind the old recycling garage. Buildings and Grounds Commissioner will have the DPW clean up the area.

OLD BUSINESS

The renewal contract for the Animal Control will be discussed at the next meeting. Council will be reviewing it. Councilman Andrews has been trying to get quotes for a generator for the Borough Hall but due to the storm things have been slowed down. He will continue to pursue getting prices. Councilman Hann informed Council that he will be speaking with the Fire Department regarding the catering for the Christmas party and will have an answer for the next meeting. Councilman Andrews informed council that the Police Department purchased another computer in the amount of \$567.51 including the software.

Steven Verberski, owner of 345 Main Street asked Council if he could put the garbage cans on the side of the apartment area. He stated that his tenants are afraid to take their garbage out at night because of the bears. He said he as a fence on the side of the apartments and would like to incorporate the garbage cans in the fenced in area. Mr. Verberski was informed that he would have to speak with the Zoning Official or the Land Use Board regarding the matter.
