### REGULAR MEETING

### MARCH 10, 2014

The third regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey was held in the Council Chambers of the Borough Hall on March 10, 2014. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Amodeo, Hutnick, McGuire, Opilla, Rizzo. Absent: Astor. Also in attendance was Borough Attorney, Michael Garofalo.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 2, 2014.

Councilman McGuire moved, Councilman Opilla seconded motion to approve all items on the consent agenda.

## **OLD BUSINESS**

Councilman McGuire spoke about the cameras for the Department of Public Works. He has obtained two more quotes which are comparable to what he already has. Councilman McGuire called two to three other places and never heard back. Councilman McGuire said that he could have a demonstration done by one of the company's. Mayor Ciasullo thought that before the Borough goes any further it would be a good idea to have a demonstration done to make sure it is the type of camera that is needed. Mayor Ciasullo briefly mentioned that the Borough had two budget meetings and we will be ready to introduce the budget on March 24, 2014 provided there are no further changes. The Mayor stated that we are looking at zero increase for municipal 2014 taxes.

## **NEW BUSINESS**

Chris Stelma from Fielders Choice attended the meeting to discuss upgrading the ball field. They will be renting the field for games and Chris would like to revamp the field. They would like to donate clay to be used to fix the areas needed. The clay runs about \$800 to \$1,200. Chris Ross, DPW Supervisor asked Mr. Stelma for a proposal. Mr. Stelma also said they would be willing to help with some of the work to be done. Fielders Choice would also like to make a donation.

Councilman Opilla moved, Councilman McGuire seconded motion to open the public session of the meeting. Yeas: Amodeo, Hutnick, McGuire, Opilla, Rizzo.

Mayor Ciasullo wanted to state that the field will probably be used more this year then it has been in a long time. Between Fielders Choice using the filed for three days a week and Wallkill Little League using the field for three days overlapping on Saturdays and then Wallkill soft ball team using it two days a week. The Mayor will be looking at the game schedule and if there is an opening because of an away game that would open the field for another day. If the town needs the field for anything, then the town can also use it.

There being no business from the public, Councilman McGuire moved, Councilman Opilla seconded motion to close the public session of the meeting. Yeas: Amodeo, Hutnick, McGuire, Opilla, Rizzo.

Councilman McGuire moved, Councilman Opilla seconded motion to adopt the following resolution.

After returning from executive session at 9:35 p.m. Mayor briefly discussed some changes to the budget that he didn't mention before. Councilman McGuire asked about the Court and their employees. Mayor Ciasullo stated he called down to the Department of Personnel three times and still has not heard back from them. The Mayor left a message that they will not being doing anything by the end of the week. The Borough is still trying to work on a shared service and until the Mayor hears back from Department of Personnel he will not be doing anything.
