## REGULAR MEETING JUNE 8, 2015

The sixth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey, was held in the Council Chambers of the Borough Hall on June 8, 2015. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Astor, Hutnick, (arrived at 7:25 p.m.) McGuire, Rizzo, Opilla, Rizzo, Slater. Also in attendance was Borough Attorney Richard Brigliadoro.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 5, 2015.

Mayor Ciasullo presented Officer Geene and Sergeant Gordon a plaque for a life saving event. Mayor Ciasullo explained the life saving event. Officer Geene and Sergeant Gordon thank the Mayor and Council for the recognition. Mayor Ciasullo commented on how proud he is of the Police Department and to have such a great police force working for the Borough of Ogdensburg. Sergeant Gordon also gave a brief speech recognizing Officer Geene and his quick response to a life and death situation.

Councilman Astor moved, Councilman McGuire seconded motion for approval of items on the Consent Agenda.

Councilman McGuire moved, Councilman Opilla seconded motion to adopt the following resolution.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Ogdensburg that the following resident/residents will receive credit for an overbilling on their account.

## **OLD BUSINES**

The Mayor and Council have received numbers regarding the analysis report for Heaters Pond Dam. Mayor Ciasullo mentioned that once they go over the numbers he would like to set up a meeting for the public and also send out information for the public so they can be informed on what needs to be done. The Council decided on July 27<sup>th</sup> at 7:00 p.m. to hold a meeting to discuss the alternatives for Heaters Pond. The Mayor will have a sub-committee to work on the project. The Mayor feels they should also do a referendum.

## **NEW BUSINESS**

Councilman Hutnick informed Mayor and Council that some residents were asking about having an Ogdensburg Day. They are looking at a date of September 19<sup>th</sup> with a rain date of September 20<sup>th</sup>. Councilman Hutnick also mentioned the idea of getting security cameras for Memorial Park because of the mischief especially by the Gazebo. A suggestion was made to remove the railings on the Gazebo to cause a more open area, which would be better for surveillance purposes.

Councilman McGuire spoke about refinancing outstanding Municipal Water Loans of \$1,770,981.18. If the municipality keeps the same term due in 2040, the savings would be an estimated \$306,824.01. The shorter term would be due in 2036, with an estimated savings of \$552,152.11. The difference between the two plans would be over \$220,000.00 savings. These figures are all estimates. The CFO recommends the shorter term. Councilman McGuire moves, Councilman Astor seconded motion to do a resolution to refinance the Municipal Water Loans for the shorter term. Yeas: Astor, Hutnick, McGuire, Opilla, Rizzo, Slater.

The Mayor had asked the Department of Public Works to attend the meeting to discuss an issue with one of the fields that had not been mowed in a timely manner and caused some complaints. The Supervisor of the Department of Public Works explained what happened with the mowing of the field and informed the Mayor that the field is now playable and there is no further problem. The Mayor let the department know that he wants the field maintained and to keep on top of it. The Mayor also spoke about sick time and informed the DPW employees that sick time is to be used for when you are sick. The Mayor went over the policy and also stated that every six months time sheets will be pulled for review by Council.

Councilman Hutnick moved, Councilman Astor seconded the motion to accept the following applicants into the Ogdensburg Fire Department: Yuriy Duzinkevych, Victor DelGrosso and Kevin Weissmuller. Yeas: Astor, Hutnick, McGuire, Opilla, Rizzo, Slater.

Councilwoman Slater informed Council that a business owner in town wants to go to Heaters Pond but he is not a property owner. Council discussed the situation and Councilman McGuire made a motion to allow a business owner the use of Heaters Pond. After another brief

discussion, Councilman McGuire withdrew his motion and Councilman Astor moved, Councilman Opilla seconded to allow business owners who operator in the Borough to use Heaters Pond. Yeas: Astor, Hutnick, Opilla. Nays: McGuire, Rizzo, Slater. There being a tie, the Mayor votes to break the die. Mayor Ciasullo voted no. The motion did not pass.

### **PUBLIC SESSION**

Brenda Pettenger, 8 Avenue B inquired about the Bridge on Passaic Avenue. Mayor Ciasullo explained the work that was going to be done on the bridge and that construction will be started in June of 2016. Ms. Pettenger also spoke about the Miss Ogdensburg contest and mentioned that in the past the Borough has donated money towards the pageant. She also asked if the Borough would take it over. After discussing the pageant Councilman McGuire moved, Councilman Opilla seconded motion to donate \$300 towards the Miss Ogdensburg Pageant. Yeas: Astor, Hutnick, McGuire, Opilla, Rizzo, Slater. Ms. Pettenger also mentioned that if the town is going to have Ogdensburg Day that they need to have vendors at the event. Patricia Sabourin, 13 Wilson Dr. said she would like to see another category added to the pageant and have a Mrs. Ogdensburg. Jean Castimore, 62 Main Street asked if any stores were going in where the VFW property was on Rt. 517. The Mayor responded that no stores were going in.

Councilman McGuire moved, Councilwoman Rizzo seconded motion to adopt the following resolution.

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist.
