REGULAR MEETING APRIL 11, 2016

The fourth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey, was held in the Council Chambers of the Borough Hall on April 11, 2016. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Astor, Hutnick, McGuire, Rizzo. Absent: Opilla and Slater. Also in attendance was Borough Attorney, Richard Brigliadoro.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 4, 2016.

Councilman McGuire moved, Councilwoman Rizzo seconded motion to approve items on the Consent Agenda.

Prior to the approval of the consent agenda, Sergeant Joseph Sanfilippo spoke about the Click It or Ticket Grant, which is federally funded and to ask the Mayor if he would sign off on the grant. The campaign is from May 23rd to June 5, 2016 and the objective is to increase seat belt usage statewide by 1.5% to 93%. The grant of \$5,000 will pay for 100 hours of overtime enforcement during the two week period with a maximum rate to be reimbursed of \$50.00 per hour. The grant is a reimbursement grant whereby participating departments will incur all costs and then submit the necessary documentation for reimbursement. Mayor Ciasullo agreed to sign off on the grant. Yeas: Astor, Hutnick, McGuire, Rizzo.

Councilman McGuire moved, Councilwoman Rizzo seconded motion to adopt the following resolution.

WHEREAS the Ogdensburg First Aid Squad is sponsoring an Ogdensburg 5 K Fun Run and Race on Saturday, June 18, 2016. This race is known as a Major Race in a Miner Town.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Ogdensburg to endorse the Ogdensburg 5K Fun Run and Race for 2016 to be held on Saturday, June 18, 2016 pending all County requirements are met.

WHEREAS, the State of New Jersey will participate in the nationwide *Click It or Ticket* seat belt grant from May 23, 2016 – June 5, 2016 in an effort to raise awareness and increase seat belt usage through a combination of enforcement and education; and

WHEREAS, Sergeant Joseph Sanfilippo is authorized to submit a *Click It or Ticket* application on behalf of the Borough of Ogdensburg; and

WHEREAS, the Police Officers working this program will be paid \$50.00 per hour with a maximum of 100 hours not to exceed a total of \$5,000; and

WHEREAS, a further increase in seat belt usage in New Jersey will save lives on our roadways.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Ogdensburg authorizes the submission and acceptance of a 2016 Click It or Ticket seat belt grant from May 23, 2016 – June 5, 2016 and pledges to increase awareness of the benefits of seatbelt use. Copy attached as Schedule 2.

Councilman McGuire moved, Councilwoman Rizzo seconded motion to adopt the following resolution.

WHEREAS, there is a appropriation from the Council on Affordable Housing Grant in the amount of \$4,130.00 and

WHEREAS, this appropriation is no longer needed.

There being no comment from the public, Councilman McGuire moved, Councilman Astor seconded motion to close the public hearing on the above listed ordinance. Yeas: Astor, Hutnick, McGuire, Rizzo.

Councilman McGuire moved, Councilman Astor seconded motion for adoption of said ordinance. Yeas: Astor, Hutnick, McGuire, Rizzo.

OLD BUSINESS

Councilman Astor reviewed the garbage contract and discussed the different options with Council. Councilman Astor asked if we need all the options listed. After further discussion Council agreed to go with Option #1 and #2. Mayor Ciasullo spoke with Larry Kovar of Aquatic Analysis and Mr. Kovar said he is on board with Heaters Pond and just waiting for the weather to warm up. The Mayor also spoke about the individual who posted information on face book about Heaters Pond. The Mayor said he doesn't know if it was an April fool's joke or not but didn't find it funny at all. The Mayor feels that Ogdensburg has been very transparent and to do something of that nature is wrong. The Mayor had spoken to the attorney about it and not entertaining the posting would be the best solution. Mayor Ciasullo mentioned the only update he has on Heaters Pond is getting the "ok" from the State to move forward.

The Mayor spoke about the prior meeting when the State attended the council meeting to discuss the Sparta Forestry Plan. The State said the plan will not be affecting Ogdensburg. There will be no effect on water flow and the dam will not be affected. The Mayor also mentioned the cleanup by the tunnel. Some members of the Historical Society had gone down to clean up the area and the Mayor wanted to thank those who went to help clean up. Mayor Ciasullo also mentioned that the paper work is going in for the Plant St. soccer field. The Mayor spoke about Fielder's Choice and the dirt that was put down and work that was done for the field by the Firehouse. Councilman McGuire informed Mayor and Council about the estimates for the grandstand roof, which range from about \$2,000 to \$2,200. Councilman McGuire also spoke about the front steps to the Municipal Building. The Borough has quotes out and waiting to hear back. The ramp also needs to be repaired. Mayor Ciasullo mentioned that a call was made to get oil in for the First Aid Squad and Historical Society.

NEW BUSINESS

The Mayor said he is presently going over and updating the Emergency Action Plan and will be sending it over to the County. Police Commissioner Rizzo brought up the New Jersey Special Olympics and asked Chief Gordon to speak about the car wash. Chief Gordon explained that every year Officer James Lame has implemented and hosted a successful car wash event to raise money for the Special Olympics. The car wash fund raiser will be at the Ogdensburg Fire House on May 21, 2016 with a rain date of May 28, 2016. It has been such a success that the FOP wants to be on board this year to help with the fund raiser.

Councilman McGuire moved, Councilman Hutnick seconded motion to open the public session of the meeting. Yeas: Astor, Hutnick, McGuire, Rizzo.

A resident from Lake Neepaulin in Wantage asked a question regarding the amount of acres the Borough has in the Sparta Mt. Plan. The Mayor stated that he could not verify the total amount of acres. Silvia Opresnick from Sparta spoke about the Forest Management Plan and read off points of concern. The Mayor stated that the Borough's concerns were answered relating to Heater's Pond and The Department of Environmental Protection is not touching anything in Ogdensburg. There being no further business from the public, Councilman Hutnick moved, Councilman Astor seconded motion to close the public session. Yeas: Astor, Hutnick, McGuire, Rizzo.

Councilman Hutnick moved, Councilman McGuire seconded motion to open **the public hearing on Ogdensburg 2016 Municipal Budget.** Yeas: Astor, Hutnick, McGuire, Rizzo.

Borough Auditor, Thomas Ferry attended the meeting and went over the budget with Council. The 2016 budget is \$2,757,640.89 an increase of \$58,466.66 from 2015. One tax point equals \$19,664.12. Ten dollars on a \$100,000 home. Surplus balance as of 12/31/15 is \$821,075.26. Current surplus anticipated in 2016 budget is \$81,768.00. Surplus balance remaining is \$739,307.26. Mayor Ciasullo thanked the auditor and CFO for all the work they did on the budget.

There being no comment from the public, Councilman Hutnick moved, Councilwoman Rizzo seconded motion to close the public hearing on Ogdensburg 2016 Municipal Budget. Yeas: Astor, Hutnick, McGuire, Rizzo.

Councilman Hutnick moved, Councilwoman Rizzo seconded motion to adopt the 2016 Ogdensburg Municipal Budget. Yeas: Astor, Hutnick, McGuire, Rizzo.

Councilman McGuire moved, Councilman Astor seconded motion for review and approval of vouchers. Yeas: Astor, Hutnick, McGuire, Rizzo.
