REGULAR MEETING December 11, 2017

The twelfth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey, was held in the Council Chambers of the Borough Hall on December 11, 2017. Mayor Rachel Slater called the meeting to order at 7:00 p.m.

Upon roll call the following Council members appeared and answered the call: Astor, Gunderman, Hutnick, Nasisi, Opilla. Also in attendance was Borough Attorney Richard Brigliadoro.

OLD BUSINESS

Heaters Pond Dam - Mayor Slater reported she has no update on Heaters Pond Dam to date.

Repair of Loop - Councilman Opilla commented he reached out to Chris Ross regarding getting some dates on the schedule for the repair.

JCP & L - Mayor Slater commented Jackie Espinoza, from JCP & L will give us an update.

Ms. Espinoza reported this is the first time she is doing the LED transfer, she will let the Borough know when that is going to happen. Ms. Espinoza commented she doesn't recommend putting a flood light in the back of the Municipal building; there might be some complaints from the residents. Also JCP&L is not allowed to install any more polls for lighting it would have to be private electricians come in. Ms. Espinoza spoke about lights on the corner and in front of the school. There was a discussion on the crosswalk being dark and a shield for the light on 517.

Councilman Hutnick commented both lights are out by the tunnel. Chief Gordon explained the light on the north side burnt out the other day, the one on the south side a tree came down back in June and we didn't realize it took the wire down. Chief Gordon commented he put the notification into JCP&L they came out and cut the wire off but they didn't replace it.

Councilman Astor had nothing new to report regarding Predmore Road.

NEW BUSINESS

Department Positions for 2018 – Councilman Opilla commented he thought we should bring this up now, instead of waiting until January to start talking about who is going to be where in 2018.

Mayor Slater commented we are going to remove the position of Assistant Historian. We emailed Mr. Kibildis asking who will take that position and he said there never was one, there was just a local historian. The water assistant operator needs to be taken off until we get the replacement.

Mayor Slater reviewed the Borough Council committees for 2018, Parks and Playgrounds will go to Councilman Opilla, Personnel – Councilman Hutnick, Finance and Taxes is going to be the Council as a whole, Municipal Drug Alliance will be Councilman Gunderman, Municipal Insurance Commissioner will be Councilman Opilla, Residential Code Commissioner is going to be a Council as a whole. We need to get the codifications done before the end of 2018. Water Commission is going to be Councilman Elect Nardini. Emergency Management Council we are adding Allan Arduini, Chris Ciasullo and Councilman Nasisi are coming off, Councilman Astor

is going on because he is in charge at the school and for shelter reasons and Mr. Jiminez is coming off.

Municipal Court Judge Position – Councilman Nasisi commented he called Judge Gavan and offered him the position, the salary was discussed and he accepted the position.

Vehicles, Roads and Winter – Councilman Astor commented we are down a vehicle so come budget time we might want to possibly discuss a five year plan and maintenance plans as well a discussion about purchasing another vehicle. We have a dump truck from 1996 which we don't want to put any more money into it. Also we will need to discuss hiring another person for DPW. Councilman Astor commented Chris let him know last week that we are going to need to repair the roof of the salt shed.

PUBLIC SESSION

Councilman Astor moved, Councilman Gunderman seconded motion to open the public session of the meeting.

Kate McNamara, Project Self Sufficency, addressed the Council. Ms. McNamara explained the focus of their services, the needs of low income families, single parents, teen parents, parenting classes, computer classes, we have a child care center and we do basic necessities for example a food pantry. Ms. McNamara commented Project Self Sufficency is very lucky, we received last month a grant and explained the grant. Ms. McNamara explained the towns they will be servicing from the Newton Campus. We would like to work with you and take your advice on what your town needs and where might be the best place to be, whether that is by the Municipal building, the School, by a church or by a store. Ms. McNamara commented she will be meeting with the superintendent in the school to let people know about the program.

Councilman Astor commented he can offer a onetime meeting with the superintendents of Hamburg, Hardyston, Franklin and Ogdensburg and Wallkill. Wallkill has started a food pantry. We get together every month.

There being no further business from the public, Councilman Astor moved, Councilman Gunderman seconded motion to close the public session of the meeting. All were in favor.
