REGULAR MEETING JULY 10, 2017

The seventh regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey, was held in the Council Chambers of the Borough Hall on July 10, 2017. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Astor, Gunderman, Hutnick, Nasisi, Opilla, Slater. Also in attendance was Borough Attorney Richard Brigliadoro.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 4, 2017.

Councilman Opilla moved, Councilman Hutnick seconded motion for approval of items on the consent agenda.

Councilman Opilla moved, Councilman Hutnick seconded motion to adopt the following resolution.

WHEREAS, the Borough of Ogdensburg holds a mortgage regarding a housing rehabilitation program which mortgage is subordinate to the Citibank Mortgage, and;

WHEREAS, the Borough of Ogdensburg is named as a defendant in the mortgage Foreclosure action filed by Citibank N.A.

NOW, THEREFORE, BE IT RESOLVED the Mayor and Council of the Borough of Ogdensburg has reviewed this matter and has determined that the amount of the first mortgage in default makes it unlikely that there will be surplus funds available upon a foreclosure sale to cover the Borough's subordinate mortgage and, therefore, the Mayor and Council have

determined that it is not in the best interest of the Borough to file an answer or otherwise defend the foreclosure action in the matter of Citibank N.A. vs. Emma Salcedo, et.al. bearing docket number F-013993-17.

WHEREAS, the Borough of Ogdensburg is named as a defendant in the mortgage Foreclosure action filed by Carrington Mortgage.

NOW, THEREFORE, BE IT RESOLVED the Mayor and Council of the Borough of Ogdensburg has reviewed this matter and has determined that the amount of the first mortgage in default makes it unlikely that there will be surplus funds available upon a foreclosure sale to cover the Borough's subordinate mortgage and, therefore, the Mayor and Council have determined that it is not in the best interest of the Borough to file an answer or otherwise defend the foreclosure action in the matter of Carrington Mortgage Services, LLC vs. Henry T. Goldsworthy, et.al. bearing docket number F-0130690-17.

OLD BUSINESS

Mayor Ciasullo mentioned that the bid for Heaters Pond was advertised and the bid opening will be on July 28, 2017. Councilman Opilla mentioned that they are almost ready to go, but the CFO was asking for a second quote so the DPW Supervisor is still working on it. Mayor Ciasullo spoke about Elizabethtown Gas mentioning that there will be a meeting at the Firehouse on Thursday, July 13th at 7:00 p.m. Prior to this meeting there were a couple of other meetings which the Mayor met with the representatives of Elizabethtown Gas to discuss gas lines. The Mayor also mentioned that about two weeks ago a flyer was sent out to residents advertising the meeting on Thursday and signs were dropped off to make the public aware of the meeting with Elizabethtown Gas regarding the installation gas lines. Councilman Hutnick spoke about Ogdensburg Day. The contract for the rides is getting finalized and vendors for food and other items are coming together.

Councilwoman Slater spoke about Heaters Pond and the fact that residents must have a badge to be at Heaters Pond. She also mentioned that on the form to purchase badges will be added a hold harmless clause. Councilwoman Slater gave a run down on what is included when you purchase a badge. She would like to look at the policy to see if it can be simplified regarding badges and boat permits and stated the need to enforce badges and boat permits. Councilwoman Slater looked into how many lifeguards are needed if they purchase the new slide. One lifeguard with the slide would be enough. Councilwoman Slater mentioned that she saw a pool floating slide and will look into it. Also mentioned that the water is not deep enough for diving off the dock and signs need to be posted. The ORA posted signs at the swim lane docks about no fishing being allowed from the swim lane docks. Councilwoman Slater mentioned that the bubbler in the pond needs to be fixed. A brand new bubbler would cost \$2,300. Mayor Ciasullo stated he would like to fix the bubbler if possible. Councilman Astor informed Mayor and Council that he spoke with one of the inspectors regarding the Passaic Ave. Bridge and was told that there were some issues that came up and now they are looking at an opening date of October 15th. Councilman Nasisi mentioned that the permits are ready for the removal of the oil tank and will be pulling the oil tank in the next two weeks. Mayor Ciasullo mentioned that the Clerk will be

leaving and they will need to put something together to advertise. The Mayor asked the Council to think about if they want to combine a Clerk/Manager position or not so an ad can be placed.

NEW BUSINESS

The Water and Operator Maintenance list was tabled. Councilman Hutnick informed Mayor and Council that on July 12th, the Cake Boss will be at the Sterling Hill mines doing a filming at 12:30 p.m. David Astor and some students will be part of it.

PUBLIC SESSION

Councilman Hutnick moved, Councilman Opilla seconded motion to open the public session of the meeting. Yeas: Astor, Gunderman, Hutnick, Nasisi, Opilla, Slater.

Vicky Schroeder, 60 Center St. informed Mayor and Council that her water pressure is very low. Mrs. Schroeder was told to call the Water Dept. to get on a schedule to have the Department of Public Works come out to check the pressure to see if it's at the road or within her property.

Jackie Espinoza, from Jersey Central Power and Light attended the meeting and spoke about the accident on Rt. 517 over the weekend and to see if Franklin can be linked to the Sparta Line. Ms. Espinoza spoke about LED lighting for Main St. Mayor Ciasullo suggested putting one light in to try and see how it looks. Councilman Nasisi asked if there are any energy credits given with the lighting. Ms. Espinoza said there weren't but there is no charge for changing the lights.

Contractor Holden Schwabe of Schwabe Contracting Inc. attended the meeting with Harry Patel who owns Sam's Deli. Mr. Schwabe said Harry would like to extend the parking area and also put picnic tables beyond the parking area. Mr. Schwabe presented a small plan to the Council on what he would like to do. The Mayor explained to Mr. Schwabe that first he must go before the Land Use Board and Council would have to look into whether the Borough would rent the space, insurance issues that must be covered along with other items. The Borough attorney suggested doing a conceptual plan for the Land Use Board for them to look at.

Councilman Astor moved, Councilman Hutnick seconded motion to adopt the following resolution.

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist.
