ORDER OF BUSINESS

Presentation by Elizabethtown Gas.

Gary Marmo, representing Elizabethtown Gas explained a slide show and informed the public they could ask questions anytime during the presentation.

Mr. Marmo explained the process to converting your home to natural gas; natural gas is affordable and showed a comparison to propane and oil. Mr. Marmo explained the different piping used and showed sample of a meter Elizabethtown Gas would use on your home.

David Snyder, FrasAir, explained the cost involved with the inside of the house, an estimated cost to switching over the boiler, stove dryer and gas fireplace and showed an example of different working conditions.

One member of the public questioned the type of pipes that would be used. Mr. Snyder explained the different kind of pipes that would be used.

Mr. Snyder explained if someone has forced hot air, the cost of good, better and best for furnace efficiency.

Question from the public regarding the lime in the water. Mr. Snyder explained the need to get a water softener.

Public question; to run the line to the house can you only connect heat or do you have to connect everything. Mr. Marmo explained Elizabethtown Gas is looking for heat and hot water commitment.

Public question; can you do the appliances later. Mr. Snyder explained it is wiser to connected everything at once and have everything inspected at once with one permit.

Public question; does the Elizabethtown Gas run the line right to the house. Mr. Marmo explained to the front or corner of the home.

Susan Buck, stepped forward and explained rebates available, she helps along with Elizabethtown Gas with programs and gave an example if the meter is on the house and you have an account number you would qualify for a rebate. The clean energy program and free home energy assessment was also explained.

Debra McGrath, realtor stepped forward and explained the benefits when selling a home that has natural gas or the possibility of hooking up to natural gas.

Public question; what happens to the old oil tank. Mr. Snyder explained someone in the back of the room can explain that to you.
