Mr. Cruz commented he has a beautiful wife and three children. Mr. Cruz commented he wants to give back to the community, I love it here, it is a great town and wants to be a part of it somehow.

Mayor Hutnick commented that is the name we were given. Mr. Cruz commented really.

Mr. Cruz commented my wife is Jane Acosta Cruz. That got messed up. Mayor Hutnick commented they sure did.

OLD BUSINESS

Borough Hall Roof— Councilman Nasisi commented we had some packets go out. Ms. Hough commented we had the bid opening; three bids were submitted the resolution is on the agenda. Ms. Hough explained the lowest bid. Mr. Vreeland was here to open the bids and Ms. Hough records them. Ms. Hough explained Mr. Vreeland called today and said there is going to be a pre construction meeting and asked Councilman Nasisi if he would like to be present at that meeting. Councilman Nasisi commented yes. There was a brief discussion on the bids. Ms. Hough commented in the packets there is the bid the Council is awarding. Councilman Nasisi commented this automatically ran itself.

Steam Boiler for Historical Building – Councilman Nasisi commented the boiler is in; so that is good news. The next item is next year we are going to remove the underground oil tanks that are over there [at the Historical Building] get those out and make sure there are properly abandoned. We can pull this off the agenda for now.

Building/Grounds Differentiations – Councilman Nasisi commented there is no update on this.

Salt Shed Roof – Councilman Nasisi commented he has one quote so far for the salt shed roof for seventy five hundred.

Councilman Nardini commented with the water getting in the salt this is a priority.

Councilman Nasisi commented now it is covered; when we had this guys come out to give us a quote he had sheets of plywood to put over the wholes for now.

Employee Handbook- Councilwoman Slater commented Mr. McBriar needs a little more time to get some stuff done; we also want to include health insurance stuff that we are going to be doing with the dental and the vision so that will go in there. Hopefully by the reorg meeting we will have it.

Water/DPW duties/Projects – Councilman Nardini commented water and DPW has been a very busy couple of weeks. We actually didn't do any improvement with the delays; the guys are on top of everything the best they could. We had an issue with one of the pumps on the plow on one of the smaller trucks so we have to bring that in for service. Jim was working on it actively and getting it to work for a short period of time. It was working for the majority of the time because they were barely keeping up. Rob was on top with the generator, we lost power everywhere; Rob and Chris were down there Wednesday morning putting diesel in the generator; that never stopped working. DPW had garage door failure so the motor brook on the doors so that have to get that fixed; the chain saw broke doing some extra clean up.

Police – Mayor Hutnick asked if the new hire started yet. Councilwoman Slater commented he was finishing up the last part of what the process was. Mayor Hutnick commented we have a new officer he will start the academy in January after the Chief is doing all he has to do.

Surplus Property – Mayor Hutnick commented this is old there is nothing new. Councilman Nardini commented we have a couple of days left for the auction. The one truck had a lot of going back and forth and explained. There was a brief discussion on the surplus property being auctioned.

Subordination of Housing Rehabilitation Loan - Mr. McBriar commented this was done at the last meeting; we can remove this.

Speed Bumps on Passaic Ave and Plant Street – Mayor Hutnick commented we will table this until we figure it out. Ms. Hough asked should I remove this. Mayor Hutnick commented yes until we get the right answers.

NEW BUSINESS

Storm Overview – Mayor Hutnick commented we are one of the few towns that were 100 percent without power for as long as we did. Which is unacceptable due to the fact our DPW guys did the bulk of the clean up to make sure the roads were open so the crews could come in. Mayor Hutnick commented he wanted to give kudos to the DPW for going above and beyond making sure they were out with chain saws, trackers, pulling and moving and doing everything they need to do to keep this town flowing and safe.

Mayor Hutnick commented he had a meeting Sunday it was kind of a quick think which he didn't think was going to happen with Congresswoman Mikie Sherrill and Senator Stephen Oroho. We discussed problems and what we need for the future. We took a quick drive around town so they could look at things to see what was what. Mayor Hutnick commented he has no idea what will come out of it. Mayor Hutnick commented he is looking for money to help us clean up, he is also looking for generators for the fire department and the first aid squad not home generators full building generators. The money is there we just have to figure out how to get it because the Governor didn't declare a state of emergency for us.

Councilwoman Slater asked if our OEM coordinator did anything reported anything. Mayor Hutnick commented he hadn't heard anything; he hadn't declared for OEM to take over. Mayor Hutnick commented he knows he gave out our generators to the medically needed. Surprisingly there were more people in town that need generators than he would have thought. We covered as much as we could; the Police did what they could.

Mayor Hutnick commented the Ogdensburg Fire Department responded to 12 calls during the week during the storm. That was part of the County break down.

Ogdensburg Fire Department as a Shelter – Mayor Hutnick commented everyone around us has a shelter but we don't. Franklin and Sparta does but Ogdensburg has none; he has spoken to the Fire Department and they [agree] to make the fire department an official shelter and get a full natural gas generator there. Mayor Hutnick commented it is ridicules having Vo Tech as a shelter but you have to travel through the storm to get there. Mayor Hutnick commented he has a meeting tomorrow night with the First Aid Squad to discuss with them making the First Aid Squad a shelter as well that way we will have one on each side of town in case the center gets blocked.

Councilwoman O'Dell commented she spoke to Mr. Astor about the school and he is under the impression there is a hold up if there are no showers that work; but he doesn't know if they work because they don't use them.

Councilman Nasisi commented that comes under the definition of what type of a shelter.

Councilwoman Slater commented to have an actual shelter you have to have running water so you can shower.

Councilman Nasisi asked about having it as a warming station.

There was a discussion on a shelter and having a warming station.

Councilwoman O'Dell commented it was suggested we get a master list of the sick and the elderly who require medical [needs].

Mayor Hutnick commented the individuals are supposed to report that to the police and fire. So if you are sick and have medical equipment and special needs you are supposed to notify the police department so if something happened [they know].

Councilwoman Slater commented OEM Coordinators are supposed to follow up with them.

Councilwoman O'Dell commented is there something we can do on top of that to ask residents [again].

Mayor Hutnick commented we can put out there as a reminder [something] if you have special needs, medical needs whatever to get on the list.

Councilwoman Slater commented to contact the police department first, let them do the list since they will be first ones to respond anyway. They create the list provide it to Robin then Robin can provide it to the OEM coordinator and the Chief of the Fire Department. The last time there was a storm the fire department went around door to door asking everybody.

There was a discussion on the next flyer and to update this information. Councilwoman Slater commented the residents have to realize if it is an emergency they have to call 911 she doesn't want people thinking the power is out so we are coming to get them if it is an emergency they need to call 911 and they will come to get them or if they have to be evacuated we will do it that way but she doesn't want them to assume the fire department is coming to get them. Mayor Hutnick commented once the emergency generators were given out there was nothing we could have done afterwards for the extra phone calls.

There was a discussion on Elizabethtown Gas and running the gas lines to the first aid squad and other areas of town.

Brush Clean Up Tree Removal – Mayor Hutnick commented with regards to brush and tree removal we are getting a lot of phone calls from residents asking if we are going to pick up the brush. When trees are on your property technically it is not the town's problem however we are looking into something or we will be looking into something that isn't going to happen right away to put together a plan to see what we can do as far as tree services or us. It depends if we have the money. This isn't brush and pick up time this is a mass clean up.

Mayor Hutnick commented he was told that we have a chipper but it is out on a loan. Does anyone know anything about that? The Borough owns a chipper but it is in Lafayette.

Councilwoman Slater commented do we own it or did we borrow it from them; this is a problem we had in the past when we had a shared service agreement but we actually never really had a shared service agreement.

There was a discussion the chipper and equipment that has been shared with Lafayette and turning power back on to houses with wires down from individual houses and if permits are needed.

Plant Street/Passaic Ave Grant scope of work – Councilwoman Slater commented in all of your packets are the applications for the two grants that we received. At the one meeting it was discussed what we are going to do with the money; it is not what we are going to do with the money we can only do what is in the application and what it is approved for. There are no speed bumps being done with this money, no sidewalks being done with this money. If you look at both of the applications you will see that there are different things that have to be checked off

with what we are applying for and both were check for roadway preservation. Councilwoman Slater referenced the second page there is a scope of work for each of them and that is what the approval of the money is for. Councilwoman Slater read the scope of work for Plant Street that is in the application. That is what the money is going to be used for. Councilwoman Slater commented she did ask Robin cause there is a sheet in there with the engineers estimate she asked Robin to have the engineer to go back through this and see what we can get done with what we got approved for, asked for some clarifications on different items in the estimate and explained.

Mayor Hutnick commented it is not just open money it is specifically for this.

Councilwoman Slater commented she did ask Robin when they fill out these applications before they submit them the Council should be copied on them so we know what options they are checking and what to apply for.

Mayor Hutnick commented that will be changing this year.

There was discussion on the grants and the grant for the storm drains.

Councilwoman Slater asked if Van Cleef is going to apply for the storm drain grant. Councilman Nardini commented right now Steve [from Bruno Associates] has it. Van Cleef is almost done with the map, Chris plotted on the map Van Cleef is finalizing it and then it is going back to Steve to put it through.

Councilwoman Slater commented just have Van Cleef do it.

There was a discussion on the catch basins.

Councilman Nardini commented as far as he know they have the application done and are waiting on the supporting documentation so catch basins is in and done once we get Van Cleef stuff; but I will clarify this tomorrow.

Mayor Hutnick commented in front of you everyone has a packet that says the State of New Jersey 218th Legislation which is a bill Senator Oroho is working on right now. It is vegetation management and explained the legislation to the Council. Mayor Hutnick commented to take this home and look at it.

PUBLIC SESSION

Councilman Cruz moved, Councilman Nasisi seconded motion to open the public session of the meeting. All were in favor.

Vicki Schroder 60 Center Street, commented she is proud to be from Ogdensburg this week, you guys did an amazing job, DPW, Police Department, Fire Department, everyone on Facebook was saying they wished they lived in Ogdensburg and wished their elected officials kept them as update as we did. Mrs. Schroder thanked everyone for everything that was done.

There being no further business from the public, Councilman Cruz moved, Councilman Nasisi seconded motion to close the public session of the meeting. All were in favor.
