ORDINANCE 03-2019**

**AN ORDINANCE OF THE BOROUGH OF OGDENSBURG APPROVING
A DRUG FREE ZONE MAP**

WHEREAS, the Mayor and Council of the Borough of Ogdensburg supports efforts to investigate and prosecute drug offenses; and

WHEREAS, New Jersey law provides specific protection for areas around school property and the property of a public housing facility, a public park or a public building; and

WHEREAS, N.J.S.A. 2C:35-7 allows the Prosecutor to use an approved map for the purpose of depicting the location and boundaries of the area on or within 1,000 feet of any property used for school purposes; and

WHEREAS, the attached map also includes the location and boundaries of the area within 500 feet of the property of public housing facility, a public park or a public building; and

WHEREAS, the Borough has reviewed the attached Drug Free Zone Map prepared by Eugene Buczynski, Borough Engineer, Van Cleef Engineering Associates dated January 23, 2019.

**NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE
BOROUGH OF OGDENSBURG AS FOLLOWS:**


Section 1. The Mayor and Council of the Borough of Ogdensburg approves the Drug Free Zone Map prepared by Eugene Buczynski, Borough Engineer, Van Cleef Engineering Associates dated January 23, 2019 as an official finding and record of the location and boundaries of the area or areas on or with 1,000 feet of school property and 500 feet from a public housing facility, a public park and public building for the purposes set forth in N.J.S.A. 2C:35-7.


Section 2. All Ordinances or parts of Ordinances inconsistent herewith are repealed.


Section 3. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

Section 4. This Ordinance shall become effective after second reading and publication as required by law.


