**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 7
TRAFFIC SECTION 7-14 PARKING PROHIBITED AT ALL TIMES ON
CERTAIN STREETS OF THE CODE OF THE BOROUGH OF
OGDENSBURG**

WHEREAS; the Borough of Ogdensburg (“Borough”) desires to amend and supplement chapter 7, Traffic section 7-14 Parking prohibited at all times on certain streets of the Code of the Borough of Ogdensburg.

NOW THEREFORE, be it ordained, by the borough Council of the Borough of Ogdensburg, County of Sussex, State of New Jersey, that; chapter 7 of the Borough Code is hereby amended, revised and supplements as follows:

Section 7-14 PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS
No Person Shall Park a Vehicle at anytime upon any street or parts there of described.

Delete the following from this section

Name of Street	Side	Location
Firehouse Lane (access Road to the Ogdensburg Municipal Park)	Northerly	Along the guard rail, as posted

Add 7-14.1

NO PARKING FIREHOUSE LANE.


Section 2. All Ordinances or parts of Ordinances inconsistent herewith are repealed.






