ORDINANCE 06-2019**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 2,
ARTICLE III, SECTION 2-19.16 OF THE CODE OF THE BOROUGH OF
OGDENSBURG ENTITLED "REQUIREMENTS AND FEES FOR
OFFICERS PERFORMING QUASI-PUBLIC POLICE SERVICES"**

WHEREAS, the Borough of Ogdensburg ("Borough") desires to amend and supplement Chapter 2, Article III, Section 2-19.16 of the Code of the Borough entitled "Requirements and Fees for Officers Performing Quasi-Public Police Services."

NOW THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Ogdensburg, County of Sussex, State of New Jersey, that Chapter 2, Article III, Section 2-19.16 entitled "Requirements and Fees for Officers Performing Quasi-Public Police Services" of the Code of the Borough ("Code") is hereby amended, revised and supplemented as follows:

SECTION 1. Chapter 2, Article III, Section 2-19.16(c)(1) of the Code is hereby replaced in its entirety as follows:

Section 2-19.16 Requirements and Fees for Officers Performing Quasi-Public Police Services

- c. *Deposits.* Whenever an application for quasi-public police services is approved as set forth above, the applicant requesting the service shall place an escrow with the Borough of Ogdensburg as follows:
 - 1. The applicant shall submit a fee of \$85.00 per hour for any police officer being requested to work quasi-public police services; and

SECTION 2. All Ordinances or parts of Ordinances inconsistent herewith are repealed.


SECTION 3. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall become effective after second reading and publication as required by law.
