ORDINANCE 09-2019**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 2  
“ADMINISTRATION,” ARTICLE VII “ADMINISTRATIVE FEES” AND CHAPTER 30  
“LAND DEVELOPMENT,” SECTION 30-1000 “ADMINISTRATION, WAIVERS,  
ENFORCEMENT, VIOLATIONS AND PENALTIES” OF THE CODE OF THE  
BOROUGH OF OGDENSBURG**

**WHEREAS**, the Borough of Ogdensburg (“Borough”) desires to amend and supplement Chapter 2 “Administration,” Article VII “Administrative Fees” and Chapter 30 “Land Development,” Section 30-1000 “Administration, Waivers, Enforcement, Violations and Penalties” of the code of the Borough (“Code”).

**NOW THEREFORE, BE IT ORDAINED**, by the Borough Council of the Borough of Ogdensburg, County of Sussex and State of New Jersey, that Chapter 2 “Administration,” Article VII “Administrative Fees” and Chapter 30, “Land Development,” Section 30-1000 “Administration, Waivers, Enforcement, Violations and Penalties” of the Borough Code are hereby amended, revised and supplemented as follows:

**SECTION 1.**The following fee section shall be added to Chapter 2 “Administration,” Article VII “Administrative Fees”:

**2-63.6 Zoning Permit Fees.**

**SECTION 2.**The following fee section shall be added to Chapter 2 “Administration,” Article VII “Administrative Fees”:

**2-63.7 Retail Food Establishment.**

**SECTION 3** the following fee section shall be added to Chapter 2 “Administration,” Article VII “Administrative Fees”:

**2-63.8 Septic Fees.**

**SECTION 4.** Chapter 30, Section 30-1002(E)(2)(c) is hereby replaced as follows:

**30-1002 ENFORCEMENT**

(2) Certificate of Occupancy/Approval




**SECTION 5.** All Ordinances or parts of Ordinances inconsistent herewith are repealed.

**SECTION 7.** This ordinance shall become effective after second reading and publication as required by law.




