REGULAR MEETING May 13, 2013

The fifth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey was held in the Council Chambers of the Borough Hall on May 13, 2013.

Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Amodeo, Andrews, Astor, Hutnick, McGuire. Absent: Opilla. Also in attendance was the Borough Attorney, Michael Garofalo.

WHEREAS, the Annual Report of Audit for the year 2012 has been filed by a Registered Municipal Accountant with the Municipal Clerk as per the requirements of N.J.S.A. 40A5-6, and a copy has been received by each member of the governing body, and

WHEREAS, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34, and

WHEREAS, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

General Comments Recommendations

and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General Comments Recommendations

as evidenced by the group affidavit form of the governing body, and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board, and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the promulgation's of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 – to wit:

R.S. 52:27BB-52 – "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousands (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Ogdensburg, hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

Public hearing is schedule for May 27, 2013.

BE IT ORDAINED by the Mayor and Common Council of the Borough of Ogdensburg that:

1. The following salaries for the offices hereinafter set forth for the year 2013 beginning January 1st, and each year thereafter until amended or repealed, are hereby established and fixed as the salary to be paid for the offices wherein the salaries are set at fixed figures, and for the offices wherein a minimum and maximum range is set for the salaries, the salaries shall be paid to the holder of said offices within the minimum and maximum range set by resolution of the Mayor and Common Council, to wit:

- 5. All prior salary ordinances adopted by the Borough of Ogdensburg and any other ordinance or ordinances or portions thereof that may be inconsistent with the provisions of this ordinance are hereby rescinded.
- 6. This ordinance shall become effective upon adoption and publication according to law. Yeas: Amodeo, Andrews, Astor, Hutnick, McGuire. Copies attached as Schedule 10.

Councilman McGuire moved, Councilman Astor seconded motion to introduce an ordinance entitled **AN ORDINANCE FOR THE REVISION TO THE FEE ORDINANCE FOR USE OF MUNICIPAL FIELDS** on first reading. Public hearing is scheduled for May 27, 2013. **BE IT ORDAINED** by the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey as follows:

Section 1.

The following fees should be added to Chapter II, Section 2-11 of the General Ordinances of the Borough of Ogdensburg.

Fee for use of municipal fields: Daily range \$10.00 to \$100.00.

(The Mayor may waive all or part of the fees in his discretion)

Section 2. Effective Date.

This ordinance shall become effective upon adoption and publication in accordance with Law. Yeas: Amodeo, Andrews, Astor, Hutnick, McGuire. Copy attached as Schedule 11.

Councilman Astor moved, Councilman Amodeo seconded motion to open the public session of the meeting. Yeas: Amodeo, Andrews, Astor, Hutnick, McGuire.

Robert Armstrong, Chair for the Land Use Board gave an update on the Main Street Streetscape. Mr. Armstrong stated that the Borough Engineer and Van Cleef Engineering met with the County Engineers and had four changes that they wanted to make. Hopefully, the County and the State will approve the plans soon and the Borough will be able to go out to bid in June. Mr. Armstrong went over the changes from the County.

Christopher Peterson from Scout Troop 87 attended the meeting to inform Mayor and Council that his project had been approved and he can start the work. He would like to start by the end of June.

Kathy Kieb, Tax Assessor attended the meeting to briefly speak with Council about the reassessment of the Borough. She has sent out three quotes and received two quotes back. Ms. Kieb was asked to send out two more quotes as per Council. Because of the difference in quotes from the first mailing Councilman McGuire stated he will call the County Administrator to discuss. Once a decision has been made a resolution will be done.

There being no further business from the public, Councilman McGuire moved, Councilman Astor seconded motion to close the public session of the meeting. Yeas: Amodeo, Andrews, Astor, Hutnick, McGuire.

OLD BUSINESS

Councilman Andrews discussed generators and servicing. Councilman Andrews stated that he will review all the quotes and see what company will give the Borough the best service and type of generator that is needed. Councilman Hutnick stated that the website will go live sometime between Monday, May 13th and Wednesday, May 15th. Council discussed the recycling center at the Department of Public Works and fencing. To enclose an area 20x30 with a six foot high fence with a 30 foot gate would cost \$3,600. To install 2 sides would be \$1,879. A privacy fence was also discussed by Council. Mayor stated that he would like to temporarily open the old recycling center for one day a week from 8:00 a.m. to 12:00 p.m. Councilman McGuire

informed Mayor and Council that he has been trying to obtain quotes for a security camera but has not received many responses. Councilman McGuire has received one quote for \$3,001.00 and will continue to obtain more quotes. Mayor Ciasullo informed Council that the Borough has received \$5,246.91 from Clean Communities and the swim team will receive a \$500.00 grant from the monies received from Clean Communities. Councilman Andrews briefly discussed a voucher for uniforms for the Police Dept. with conflicting dates, a dollar amount and no explanation. Councilman Andrews will check with the Finance Department regarding payment. Councilman Andrews gave an update regarding a complaint from a resident on household garbage. Council briefly spoke about street sweeping. The Department of Public Works is still working on getting all the streets done.

NEW BUSINESS

Councilman Amodeo spoke about the lifeguards. There were five applications and two returns on full timers from last year. We have three new people, one from Ogdensburg and two from Franklin. The salaries ranges are from \$8.00/hr to \$11.00/hr. The two seniors who are returning are asking for \$9.75. The two from Franklin are asking under \$9.00 and the new lifeguard from Ogdensburg is asking for over \$10.00. A calendar will be put together for scheduling purposes. Councilman Amodeo also spoke about the guard shack and mentioned that the phone will need to be replaced and the lights need to be checked. Mayor spoke about a meter in a resident's home that wasn't reading correctly and the billing was incorrect. The meter was replaced with a new one and the billing is now straightened out. Councilman Astor spoke about getting a trailer that is needed for a roller and has obtained quotes ranging from \$3,435 to \$4,300. Councilman Astor also spoke about cleaning and labeling the storm drains. The cost is \$4.00 per label and then they will have to be put in. There are approximately 160 storm drains in town. With cleaning the storm drains the cost would be \$2,500 per day for Prism Maintenance to come in to do it or to rent a machine from Jet-Vac Inc. would cost \$3,500 per week. Council briefly discussed railroad pavement markings on Edison Road, which the Department of Public Works Supervisor is currently looking into getting prices. Councilman Astor informed Mayor and Council that the DPW Supervisor would like to open an account at Blue Ridge Lumber since Kuiken is no longer servicing the area.

Mayor Ciasullo spoke about the Torch Run that the Police Department takes place in to raise money for the Special Olympics and informed Council that this year Officer Lame would like to raise extra money for the Special Olympics by having a car wash. The date of the car wash will be on Saturday, May 18th with a rain date of May 25th.

Mayor Ciasullo informed Council that the Court Administrator has resigned and the Borough will have a temporary Court Administrator come in for court and also have someone for the day. The Mayor stated he would like to hire someone who is certified and also mentioned that he has reached out to Sparta to see about doing a shared service. Mayor briefly spoke about a letter the Borough received from the Department of Environmental Protection regarding an ACO with a fine of \$15,000. The Borough Attorney will look into it further.

Councilman McGuire moved, Councilman Hutnick seconded motion to review and approved vouchers for payment. Yeas: Amodeo, Andrews, Astor, Hutnick, McGuire. Council briefly discussed vouchers for police and fire vehicles, Jan Mar alarm and outside apparatus.
