BOROUGH OF OGDENSBURG COUNTY OF SUSSEX ORDINANCE 05-2023

AN ORDINANCE OF THE BOROUGH OF OGDENSBURG, COUNTY OF SUSSEX, AND STATE OF NEW JERSEY AMENDING CHAPTER 18 OF THE BOROUGH CODE ENTITLED "MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4), TIER A COMMUNITY-WIDE ORDINANCES" TO ADD NEW SECTION 18-3 ENTITLED "LITTER CONTROL"

WHEREAS, in July 2022, the New Jersey Department of Environmental Protection ("NJDEP") reassigned all New Jersey municipalities designated as "Tier B" under the Municipal Separate Storm Sewer System Permit Program (MS4 Permit Program) to "Tier A" effectively invalidating the "Tier B" permit program; and

WHEREAS, as a result of Tier A reassignment, the Borough of Ogdensburg ("Borough") is required to satisfy additional permit conditions set forth in the Tier A MS4 New Jersey Pollutant Discharge Elimination System ("NJPDES") Master General Permit renewed January 1, 2023; and

WHEREAS, Tier A NJPDES permit conditions require, among other things, that the Borough adopt and enforce community-wide ordinances regarding (1) Pet Waste, (2) Wildlife Feeding, (3) Litter Control, (4) Improper Disposal of Waste, (5) Containerized Yard Waste/Yard Waste, (6) Private Storm Drain Inlet Retrofitting, (7) Privately-Owned Salt Storage, (8) Tree Removal/Replacement, (9) Illicit Connection, and (10) Privately-Owned Refuse Container/Dumpster (optional); and

WHEREAS, the Borough desires to adopt the aforesaid ordinances throughout the course of this calendar year for better legislative management and increased public participation, which ordinances shall appear in Chapter 18 of the Borough Code entitled "Municipal Separate Storm Sewer System (MS4), Tier A Community-Wide Ordinances."

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Ogdensburg, County of Sussex, and State of New Jersey, that Chapter 18 of the Borough Code entitled "Municipal Separate Storm Sewer System (MS4), Tier A Community-Wide Ordinances" is hereby amended to add new Section 18-3 entitled "Litter Control" as follows:

SECTION 1. Section 18-3 entitled "Litter Control" is hereby added to Chapter 18 of the Borough Code as follows:

§ 18-3 LITTER CONTROL

18-3.1 Purpose.

The purpose of this Section is to establish requirements to control littering in the Borough of Ogdensburg, so as to protect public health, safety and welfare, and to prescribe penalties for the failure to comply.

18-3.2 Definitions.

For the purpose of this Section, the following terms, phrases, words and their derivations shall have the meanings stated herein unless their use in the text of the Chapter clearly demonstrates a different meaning. When not inconsistent with the context, words used in the present tense include the future, words used in the plural number include the singular number, and words used in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

LITTER

Any used or consumed substance or waste material which has been discarded, whether made of aluminum, glass, plastic, rubber paper, or other natural or synthetic material, or any combination thereof, including, but not limited to any bottle, jar, or can, or any top, cap, or detachable tab of any bottle, jar, or can, any unlighted cigarette, cigar, match or any flaming or glowing material or any garbage, trash, refuse, debris, rubbish, grass clippings or other lawn or garden waste, newspapers, magazines, glass, metal, plastic or paper containers or other packaging or construction material, but does not include the waste of the primary processes of mining or other extraction processes, logging, sawmilling, farming, or manufacturing.

LITTER RECEPTACLE

A container suitable for the depositing of litter.

PERSON

Any individual, cooperation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.

18-3.3 Prohibited Acts and Regulated Activities:

- a. It shall be unlawful for any person to throw, drop, discard, or otherwise place any litter of any nature upon public or private property other than in a litter receptacle, or having done so, to allow such litter to remain.
- **b.** Whenever any litter is thrown or discarded or allowed to fall from a vehicle or boat in violation of this ordinance, the operator or owner, or both, of the motor

vehicle or boat shall also be deemed to have violated this ordinance.

18-3.4 Enforcement

This ordinance shall be enforced by the Police Department and/or other Municipal Officials of the Borough of Ogdensburg.

18-3.5 Penalties:

Any person(s) who is found to be in violation of this Section shall be subject to a minimum fine of not less than \$50 nor maximum fine more than \$250 for each and every violation.

SECTION 2. All other provisions unaffected by this Ordinance shall remain in full force and effect.

SECTION 3. All Ordinances or parts of Ordinances inconsistent herewith are repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 5. This ordinance shall become effective after second reading and publication as required by law.
