## BOROUGH OF OGDENSBURG COUNTY OF SUSSEX ORDINANCE 10-2021

AN ORDINANCE AMENDING, REVISING, AND SUPPLEMENTING CHAPTER 2, "ADMINISTRATION," ARTICLE VII, "ADMINISTRATIVE FEES" AND CHAPTER 4, "ANIMAL CONTROL," SECTION 4-1.2, "FEE: TERM OF LICENSE" OF THE CODE OF THE BOROUGH OF OGDENSBURG

WHEREAS, the Borough of Ogdensburg ("Borough") desires to amend, revise, and supplement Chapter 2, "Administration," Article VII, "Administrative Fees" and Chapter 4, "Animal Control," Section 4-1.2, "Fee: Term of License" of the code of the Borough ("Code") to provide for, and update administrative fees required by the Borough.

**NOW THEREFORE, BE IT ORDAINED,** by the Borough Council of the Borough of Ogdensburg, County of Sussex, and State of New Jersey, that Chapter 2, "Administration" and Chapter 4, "Animal Control" of the Code of the Borough of Ogdensburg are hereby amended, revised, and supplemented as follows:

**SECTION 1.** Chapter 2, "Administration," Article VII, "Administrative Fees" of the Borough Code is hereby amended to add the following fee provision:

#### § 2-63.5 Licenses, Permits, Records and Certificates.

**SECTION 2.** Chapter 2, "Administration," Article VII, "Administrative Fees" of the Borough Code is hereby amended to add new Section 2-63.9 entitled "Redemption Calculations" as follows:

# § 2-63.9 Redemption Calculations

- a. Tax sale certificate redemptions calculations. In accordance with N.J.S.A. 54:5-54, the Tax Collector shall provide to any person entitled to redeem a certificate pursuant to N.J.S.A. 54:5-54 two (2) calculations of the amount required for redemption within a calendar year at no cost. For each subsequent calculation requested from the Tax Collector, there shall be a fee of \$50.00. A request for a redemption calculation shall be made in writing to the Tax Collector.
- b. Tax lien redemption calculations. Pursuant to, and in accordance with N.J.S.A. 54:5-97.1, the Tax Collector shall charge a lienholder a fee of \$50.00 for the calculation of the amount due to redeem the tax lien. Neither the Tax Collector nor the Borough shall be liable for an incorrect calculation. The fee paid to the municipality shall not become part of the lien and shall not be passed on to any party entitled to redeem pursuant to N.J.S.A. 54:5-54.

**SECTION 3.** Chapter 4, "Animal Control," Section 4-1.2, "Fee: Term of License" of the Borough Code shall be replaced in its entirety beginning January 1, 2022, as follows:

# § 4-1.2 Fees: Term of License

Any person applying for a license and registration, or renewal thereof, shall pay a licensing fee in the amount of \$8.80 per annum for each new or renewed license. In addition to the licensing fee, all licensees shall pay an annual sum of \$1.00 for the registration fee, \$0.20 for the New Jersey Pilot Clinic Fund, and a \$3.00 surcharge for all unneutered or unspayed animals, which shall be forward to the State Department of Health as required by law within 30 days after receipt of same. All licensing and registration fees collected by the Borough shall be forwarded to the Treasurer of the Borough. All license and registration tags, and renewals thereof shall expire January 31st of each year. Persons who fail to obtain a license and registration within the applicable time periods specified in this chapter shall be subject to a delinquent fee of \$5 per month beginning March 1st of each year.

SECTION 4. All Ordinances or parts of Ordinances inconsistent herewith are repealed.

SECTION 5. If any section, subsection, sentence, clause, phrase, or a portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 6.** This ordinance shall become effective after second reading and publication as required by law.
